Only a handful of companies operate at the true frontier of large-model research. Anthropic is one of them — and the only one built from day one around a safety-first research culture. Enterprise adoption of its Claude models is scaling faster than any software product in history.

Anthropic is a US-based artificial intelligence safety and research company, founded in 2021 by Dario Amodei and Daniela Amodei alongside a group of senior researchers who previously led the largest language-model work at OpenAI.

The company builds Claude — a family of frontier large language models used by millions of professionals and by many of the world's largest enterprises, governments and software platforms. Claude is regarded across the industry as the leading model for reasoning, long-context work, code and safety-critical deployments.

WHY ANTHROPIC WINS

Six reasons this is different.

01 **Duopoly at the frontier.**

Only Anthropic and OpenAI credibly train frontier general-purpose models. Google trails on adoption; the rest of the field is a full generation behind.

02 **Enterprise gravity.**

Fortune 500 legal, financial and consulting firms are standardising on Claude. Enterprise revenue is growing multiples faster than the consumer segment.

03 **Distribution moat.**

Native availability inside AWS Bedrock and Google Cloud gives Claude reach that pure model labs cannot match.

04 **Safety as a business.**

Regulators worldwide are converging on frameworks Anthropic already exceeds. That is a moat, not a cost.

05 **Talent density.**

The team that built GPT-2 and GPT-3 now trains Claude. Retention is at industry-leading levels.

06 **Capital & compute.**

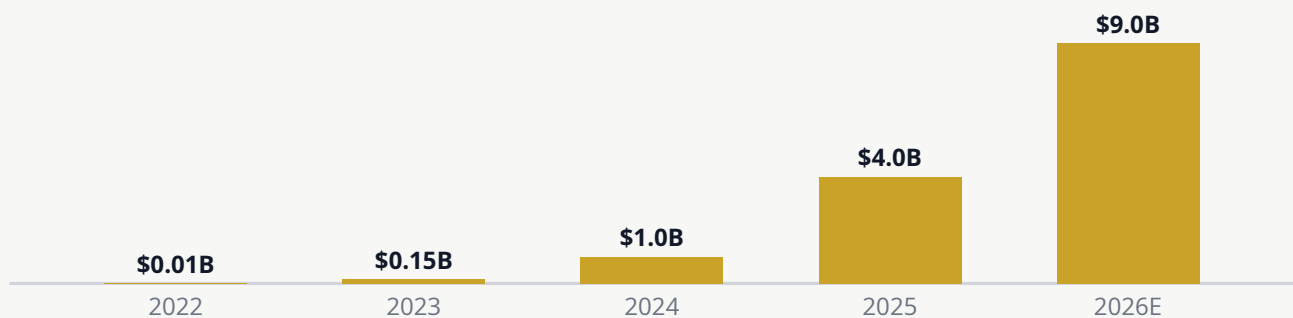
Multi-billion-dollar strategic commitments from Amazon and Google secure compute through the next model generation.

THE MARKET

A category without a ceiling.

Generative AI is not a feature — it is a horizontal input to every knowledge industry on earth. Analysts at McKinsey, Goldman Sachs and Bain estimate the annual economic impact of generative AI at between US\$2.6 trillion and US\$4.4 trillion. Model providers sit at the top of that stack.
